## ARTICLE I NAME

The name of this local organization shall be the (local organization's name) ...Business and Professional Women's Club of ... (city or town) . Ohio [you may also want to indicate affiliation with the Ohio Federation of Business and Professional Women's Clubs, Inc.
[Note: The local organization name should be the name of the community or be of geographic or historic interest or have some identifiable meaning to those who are not members.]

## ARTICLE II MISSION

The mission of this federation shall be to achieve equity for all women in the workplace and to empower all women through advocacy, education and information.
(Amended May 2020)

## ARTICLE III EMBLEM

The emblem shall be in the form of an oval pin inscribed with BPW (picture of pin to be added)
(Amended May 2020)

## ARTICLE IV POLICIES

Section $1 \quad$ This local organization shall be nonsectarian, nonpartisan, and nonprofit.
Section 2
The mission, Legislative Platform and objectives of the state federation shall in every case be the mission, Legislative Platform and objectives of all units thereof.
(Amended May 2021)

## ARTICLE V MEMBERSHIP

 individuals who support the mission, Legislative Platform and objectives of BPW/OHIO. Membership categories shall be: (Amended May 2021)
(a) Member

Membership shall be open to all
(b) Student

Individuals enrolled in college or a university, or any other accredited educational institution above the high school level.
(c) Member at Large: Individuals who choose not to belong to a local organization but support the mission, Legislative Platform and objectives. (Amended May 2021)
[Note: Local organizations may choose to establish a student level of membership and associated criteria. As an example, local organizations may wish to spell out that only full-time students are eligible, or that only day-time students are eligible, or that only nonworking students are eligible.

Section $2 \quad$ Membership in this local organization shall be all-inclusive for membership in:
(a) Ohio Federation of Business and

Professional Women's Clubs, Inc.
Section 3 A member in good standing may request transfer from one local organization to another. A local organization may not refuse to accept the transfer of a member in good standing.

Section $4 \quad$ The only criteria for membership shall be per Article V. Section 1, and the payment of appropriate dues. (Amended May 2021)
Section 5 To remain in good standing a member's dues must be current. (Amended December, 2023)

## ARTICLE VI LOCAL ORGANIZATION REQUIREMENTS

Section 1 This local organization, to remain in good standing:
(a) Shall maintain a membership of at least five (5) members and/or student members;
(b) Shall insure that the local organization bylaws are current and not in conflict with state bylaws and policies.
Section $2 \quad$ Should membership fall below five (5) members and/or student members this local organization shall be dropped at the end of the fiscal year in which the membership falls below five (5). Any remaining members will be designated as Member at Large (MAL) (Amended May 2021)

(a) All local club's resources shall be distributed per Article XIX Dissolution
(Amended Month YYYY)

## ARTICLE VII DUES

Section $1 \quad$ Dues are payable upon application for membership and renewable annually on the first day of the month following the anniversary date.
Section $2 \quad$ Member Affiliated with a Local Organization

Annual dues for each member affiliated with a local organization shall include local, region and state dues as specified in the current respective bylaws. (See Appendix for current amount.) State dues shall include a subscription to the official state publication
[Note: For local organizations adopting a student membership category, the following is a mandatory provision. Local organizations having student membership should make provisions for state and local organization dues.]

Section 3 Student
Annual dues for each student member affiliated with a local organization shall include local, region and state dues as specified in the current respective bylaws. (See Appendix for current amount.) State dues shall include a subscription to the official state publication.

Section 4 An entrance fee of $\$$... shall be paid by each new member. (See Appendix for current amount.)

Section $5 \quad$ A continuing member is one whose dues are paid in the same local organization through the close of the previous fiscal year

Section 6 A member is in good standing only when local organization, region and state dues are paid.

Section $7 \quad$ Any member who does not pay dues within ... (number) days of annual renewal date shall be removed from the local organization roster.

Note: Local organization should determine its own date for removal of names from the roster.]

Section 8 A person who has been removed from the local organization roster for nonpayment of dues may be reinstated upon payment of all delinquent dues for local organization, region and state

## ARTICLE VIII FISCAL RESPONSIBILITY

Section 1 The fiscal year shall commence on the

## ARTICLE IX OFFICERS

Section 1 The officers shall be a president, a president-elect, vice presidents [name them by title], a secretary and a treasurer.
Section 2 A term of office shall be one year.
Section 3 Officers shall assume their duties immediately following the ... (specify month) meeting and shall serve for one year or until their successors are duly elected

## ARTICLE X NOMINATIONS AND ELECTIONS

Section 1 Officers shall be elected at the local organization's annual meeting in (specify month).
[Note: It is suggested that local organization officers be elected prior to state convention.]
Section $2 \quad$ To be eligible to serve as an officer, a member must:
(a) Be in good standing and
(b) Officially and publicly support the BPW/OHIO legislative platform.

Section 3 At a business meeting preceding the annual meeting, a nominating committee of at least three members shall be elected. The nominating committee shall present to the annual meeting a slate of one or more nominees for each office. Nominations may also be made from the floor.

Section $4 \quad$ Vacancies in office shall be handled as follows:
(a) In the event of death, resignation, or incapacity of the president, the first vice president shall become the president for the unexpired portion of the term.
(b) Vacancies in offices other than president shall be filled for the unexpired term by the executive committee.
Section $5 \quad$ No member shall hold the same office for more than two consecutive terms.
Section $6 \quad$ Six months or more shall be considered a term of office in determining eligibility for re-election.

## ARTICLE XI DUTIES OF OFFICERS

Section 1 The president shall be the principal officer of the local organization and shall:
(a) Preside at all meetings of the local organization, the board of directors, and the executive committee;
(b) Appoint standing and special committee chairs [and committees] with the approval of the executive committee and may also appoint a parliamentarian [and other special appointments, i.e., legal advisor];
(c) Serve as ex-officio member of all committees except the nominating committee;
(d) Bring to the attention of the local organization all pertinent information from the state federation;
(e) Authorize all expenditures in accordance with financial policies of the local organization; and
(f) Be responsible for sending the ... (person(s) designated by the state federation):

(2) An immediate report of all changes affecting the above items.
(g) Serve on the Region's Board of Directors and encourage other local officers/members to attend regional meetings.

## Section 2 The president-elect shall:

(a) Act as representative of the president when requested;
(b) Serve as ex-officio member, without vote, of all committees except the nominating committee;
(c) ... (Local organization may assign other duties); and
(d) Serve in such other capacities as assigned by the president
Section 3 The first vice president shall:
(a) Perform the duties of the president in the absence of the president;
(b) Become president for the unexpired term in case of death, resignation, or incapacity of the president;
(c) ... (Local organization may assign other duties); and
(d) Serve in such capacities as assigned by the president.
Section 4 The second vice president shall:
(a) Perform the duties of the president in the absence of both the president and the first vice president;
(b) ... (Local organization may assign other duties); and
(c) Serve in such other capacities as assigned by the president. The secretary shall:

Take and record accurate minutes of the proceedings of all meetings of the local organization, the board of directors, and the executive committee;
(b) Conduct the correspondence of the local organization; and
(c) Preserve in a permanent file all records and letters of value to the local organization and its officers.
(a) Have charge of all monies of the local organization and shall report thereon at all meetings;
(b) Collect all monies coming into the local organization from whatever source and give a proper receipt therefore;
(c) Keep a list of the names, addresses, and occupations of all members;
(d) Pay all bills upon the written authorization of the president and/or ... (name any other person who may authorize payment of bills if desired by the local organization);
(e) Keep an itemized record, in a permanent file, of all receipts and expenditures;
(f) (Insert new dues policy here)
(g) Serve as ex-officio member of the finance committee [local organization may want to make treasurer also a member of other select committees dealing with finances, and/or may want to add that the treasurer will be bonded]; and
(h) Deliver to the successor within 15 days after expiration of term of office, all books, records, and papers, requesting receipt therefore.
7 Each officer, except for the treasurer, shall deliver to the successor immediately after retiring from office all accounts, records, books, papers, and other property belonging to the local organization.

## ARTICLE XII MEETINGS

Section 1 Regular meetings shall be held monthly on the ... day of the month unless otherwise ordered by the local
organization or the executive committee.

Note: A local organization may decide on the frequency and time of its meetings.

Section 2 The regular ... (specify month) meeting of each year shall be designated the annual meeting, at which time reports summarizing the year's activities shall be given.
Section 3 Special meetings may be called by the president or by any ... members, provided all members are notified in writing of time, place and purpose of such meeting.
Section 4 $\qquad$ members shall constitute a quorum.
Section $5 \quad$ No member shall have more than one vote, and no voting by proxy shall be allowed

## ARTICLE XIII BOARD OF DIRECTORS

Section 1 The elected officers and standing committee chairs shall constitute a board of directors.
Section 2 The board shall:
(a) Supervise the affairs of the local organization;
(b) Make recommendations for the local organization's growth and prosperity;
(c) Make recommendations to the local organization regarding proposed amendments to the bylaws;
(d) Transact any business between meetings of the local organization and report thereon at the next business meeting of the local organization; and
(e) Report at the annual meeting the business transacted by the board of directors during the local organization year.
Section 3 The board of directors shall hold a minimum of four meetings during the year, dates to be determined by the board at its first meeting.
Section $4 \quad$ Special meetings of the board may be called by the president or by one-third of the board members, provided two are elected officers.
Section 5 At the request of the President, a vote of the Board of Directors may be taken by mail, facsimile (fax), web chat or

## ARTICLE XIV EXECUTIVE COMMITTEE

Section $1 \quad$| The elected officers of the local |

| organization shall constitute the |
| executive committee. |

Section 2 The executive committee shall have authority to act for the board of directors between meetings of the board and shall report thereon at the next meeting of the board.
Section 3 The executive committee shall meet on call by the president, or by any two members of the committee, for the consideration of special matters between regular meetings of the local organization and the board of directors.
Section $4 \quad$ Standing and special committee appointments made by the president shall be subject to the approval of the executive committee.
Section 5 At the request of the President, a vote of the Executive Committee may be taken by mail, facsimile (fax), web chat or email. Such vote shall have the force and effect of a vote taken at face-toface meetings. The Secretary's records shall contain an accurate record of all such votes.
Section 6 A majority of the voting members shall constitute a quorum for a meeting of the executive committee.
Section $7 \quad$ No member shall have more than one vote, and no voting by proxy shall be allowed.

Section 8 In a local, regional, state, or national emergency declared by the Governor of Ohio or President of the United States, the board of directors shall set up machinery to carry on the business of the local organization. (Amended December, 2023)

## ARTICLE XV STANDING COMMITTEES

Section 1 The standing committees of the local organization shall be finance, foundation, programming, legislation, membership, public relations, young careerist and individual development.
[Note: There may be added standing committees, as the local organization requires.]

Section 2 To be eligible to serve as a chair or as a member of a standing committee, a member must:
(a) Be in good standing and
(b) Officially and publicly support the state legislative platform
Section 3 Committee chairs and members shall be appointed for a term of one year and may be reappointed. No person shall serve more than three consecutive years on the same committee.
Section 4 The finance committee shall be composed of a chair and ... members. It shall be the duty of the finance committee to prepare an annual budget for the local organization, to have general supervision of all expenditures, and to assist the local organization in developing a sound financial policy. The finance chair shall be a member exofficio, without vote, of all committees which disburse money.
Section 5 The foundation chair shall promote interest in and support of the National Business and Professional Women's Foundation.
[Note: Some states and/or locals may also have foundations in which case the local bylaws should make clear the committees' responsibilities.]

## Section 6

The programming committee shall be composed of a chair and members. It shall be the duty of the programming committee to plan and implement a well-coordinated annual program based on federation objectives. The committee shall meet immediately after appointment to consider the annual program suggested by the state federation and develop a program, which shall involve all areas of local organization activities. | Section 7 | The legislation committee shall be composed of a chair and ... members. It shall be the duty of the legislation committee to carry out the legislative programs adopted by the state federation. The committee shall study local legislative needs in order to make recommendations to the local organization. |
| Section 8 | The membership committee shall be composed of a chair and ... members. It shall be the duty of the membership committee to promote, expand, stabilize, and orient the membership. |
| Section 9 | The public relations committee shall be composed of a chair and ... members. It shall be the duty of the public relations committee to present state, region and local programs and activities through available news media |
| Section 10 | The young careerist committee shall be composed of a chair and ... members. It shall be the duty of the young careerist committee to encourage recruitment of young people into membership, organize and coordinate the young careerist program, and promote activities that involve the participation of young people. |
| Section 11 | The individual development committee shall be composed of a chair and .. members. It shall be the duty of the individual development committee to encourage personal development within the membership, and organize and coordinate the individual development program. |

## ARTICLE XVI REPRESENTATION

Section $1 \quad$ No individual shall have more than one vote and no voting by proxy shall be allowed.
Section $2 \quad$ Any member in good standing who has paid a full convention/conference registration fee, shall have voting privileges at the state convention of the Ohio, Federation of Business and Professional Women's Clubs, Inc.

## ARTICLE XVII PARLIAMENTARY PROCEDURE

The rules of parliamentary procedure comprised in the current edition of Robert's Rules of Order Newly Revised shall govern all proceedings of the local organization; the boards of directors, and the executive committee, subject to such special rules as have been or may be adopted with the exception that the word "chairman" be revised to gender neutral language. (Amended May 2021)

## ARTICLE XVIII AMENDMENTS

## ARTICLE XIX DISSOLUTION

Upon dissolution of this local organization all of its assets remaining after payment of all costs and expenses of such dissolution shall be distributed to the Ohio Federation, region or a local organization, or a Foundation which has qualified for exemption
under Section 501(c)(3) of the Internal Revenue Code and any applicable State tax regulations.
(a) None of the assets will be distributed to any member, officer or trustee of this organization.
(b) A letter must be sent to the $\mathrm{BPW} / \mathrm{OHIO}$

President informing the state of the intent to dissolve.
(Amended December, 2023)
